# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to https://wprapidlaunch.com, and WP Rapid Launch and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to WP Rapid Launch include https://wprapidlaunch.com. The WP Rapid Launch website is a WordPress training course site. By using the WP Rapid Launch website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, WP Rapid Launch may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase WP Rapid Launch's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. #### **Use of your Personal Information**

WP Rapid Launch collects and uses your personal information to operate and deliver the services you have requested.

WP Rapid Launch may also use your personally identifiable information to inform you of other products or services available from WP Rapid Launch and its affiliates.

#### **Sharing Information with Third Parties**

WP Rapid Launch does not sell, rent or lease its customer lists to third parties.

WP Rapid Launch may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to WP Rapid

### **Tracking User Behavior**

# **Automatically Collected Information**

#### **Use of Cookies**

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
